EVP's Report

The Most Dangerous Job in the Federal Government

In the Federal Times September 22, 2014 article, *Number of feds killed on job rises again in 2013*, they talk of the number of federal employees that were killed on the job. In 2013, 57 federal employees were killed on the job, according to preliminary data by the Bureau of Labor Statistics. That is up from 54 in 2012 and 41 in 2011. Seventeen letter carriers were killed on the job, the highest number of any agency, according to the BLS. Seven federal law enforcement officers were killed. These numbers include federal civilian employees within the states, not civilians overseas, such as Foreign Service or intelligence workers. This also excludes employees who died of an illness and military personnel.

The biggest cause of death was transportation-related accidents such as being in a car crash or being struck by a vehicle. Federal employees killed by violent acts fell last year, from 17 in 2012 to 12 in 2013. When these numbers smack you in the face, everyone should think twice about how they perceive their own safety on the job. You can never be to safe, especially when driving or where you park your vehicle. It is very easy to get complacent with your job and it becomes routine. This may result in you letting your guard down and before you know it, you have just become a statistic. Don't let this happen to you, be alert and know your surroundings, even if it's the same surroundings you pass every day.

In comparison with the private sector the federal employees have fewer fatalities per ratio. For every 36,000 employees there is one fatality in the federal workforce. In the private sector the ratio is one in 29,700. In this kind of statistical data there are no winners or losers, but it does illustrate that the letter carriers job is by far the most dangerous

Candidate Statement for President - Mark Judd

Health Benefit Open Season

The Open Season for selection and changing your health benefit plan has been announced. The Open Season period will be November 10- December 8, 2014. This will be your opportunity to enroll in the NALC Health Benefit Plan offered by your Union. Ask anyone who is a member of the plan and they are sure to tell you about the satisfaction they have with our plan as it has been ranked # 1 in customer satisfaction over the last several years. Benefits and premiums are as good, and in many cases, better than any plan in the FEHBP. If you are not a member you can go on OPM.gov and do a comparison. I am sure you will be impressed.

KIM Regional Training Seminar

Final preparations are taking place as we move closer to our KIM Regional Training Seminar October 11-13, 2014 in Detroit. Class selection is complete and instructors are preparing for what will be a great annual training. National President Fred Rolando will do his session on Sunday morning. We are always glad to have Fred with us.

Penalty Overtime Exclusion Period

As referenced in Article 8, Sections 4 and 5 of the National Agreement, the Penalty Overtime Exclusion period will be from December 6, 2014 to January 2, 2015. During this period there will be no double time payment for working over 8 on an NS day or 10 hours on a regular work day.

COLA and Wage Increase for Career Carriers

You should have noticed in your September 26, 2014 pay check COLA increases which amount to \$1,227.00 which was the deferred second COLA (\$541 or .26 cents per hour) and the fourth COLA (\$686 or .33 cents per hour) under the DAS award. In addition to these combined COLA payments, effective November 15 you will receive 1.5% wage increase of your basic annual salary for each grade and step in Table 1 and 2 of the National Agreement.

City Carrier Assistant Wage Increases

Although the DAS award did not provide for COLA for CCA's, it did provide for 6 wage increases as compared to the 3 wage increases for career employees. That said, CCA employees will receive 2.5% contractual wage increase effective November 15, 2014. The total wage increase for CCA employees over the course of the contract will equate to 7% basic hourly rate. When CCA's are converted to career status, the switch to the same pay system as career employees.

City Delivery Route Alternate Adjustment Process (CDRAAP)

After months of negotiations the National parties have reached agreement on a new route adjustment process. This process will be the only means of adjusting routes with the exception of a 271-G Special Inspection or an inspection-adjustment resulting from a grievance settlement or arbitration award. Training for NALC route adjustment teams and COR technicians will occur in October with site selection for adjustments to occur November 3-14, 2014. No adjustments will occur until after January 1, 2015.

Mandatory Park Point Safety Talks

As I reported last month we have had serious life changing injuries and deaths as a result of carriers being struck at the back of their vehicles while in performance of duty. I have reached agreement with the Great Lakes Area that the mandatory Park Point Safety talk, which should have been done in March 2012, will be given in every office and certified and validated by the NALC steward and local Management that it was given no later than October 25, 2014. 1 would advise all NALC stewards to obtain a copy after they have certified this talk was given.

That is the first part. The second part is that if any carrier has a situation with a dangerous park point and management will not move the location, please contact your branch President and they will advise me so that I can address it with the appropriate USPS official who will make the change.

I will be sending a copy of the Park Point Safety talk to every NALC branch in the region so you can make sure it is given and the proper action taken with dangerous and unsafe park points.

Interesting Facts You Should Be Aware Of

First our Region 6 CCA Union membership is 75.5% and the National CCA membership is 81%. Let's all work to get that CCA percentage in the high 90% range.

Second in this upcoming midterm elections the NALC will have 11 full time releases in Kentucky and 5 full time releases in Michigan. We need to gets friends in the Senate and Governor races that will help letter carriers in our fight against Issa and his cronies who want to destroy the Postal Service.

Third, congratulations to Branch 2184 Western Wayne County and the Lincoln Park, MI carriers who celebrated two Customer Connect sales of \$4.1 MILLION in new revenue. Great job.


