President's Report

Contract Headed To Mediation

On January 20th, the USPS declined to extend contract talks with the NALC. The decision not to extend the contract talks on our collective bargaining agreement automatically triggers an impasse which sends the collective bargaining process to mediation. Both parties are now required to enter into a 60-day mediation process. If no agreement is reached within the 60-day period the issues will then be submitted to an arbitration panel for resolution.

PTF Conversions

After filing countless numbers of grievances over the years regarding PTF conversions and maximization issues, we finally received some good news. On January 23, Branch 2184 received notice of a prearbitration grievance settlement from the National Business Agent's office. The agreement outlined the terms of the settlement between the Detroit District and the NALC. It would convert PTF's to fulltime status in certain installations for the purpose of filling residual CC 2 (T-6 Carrier Technician) positions. The following Branch 2184 offices listed were affected by the settlement: Lincoln Park - 2 PTF conversions, Inkster - 1 PTF conversion, Monroe - 2 PTF conversions, and Taylor - 3 PTF conversions. The parties are still working on further conversions to fulltime, and as we go to press we have been asked to provide additional information regarding the remaining residual vacancies in the Branch. Special thanks go out to our stewards who filed the initial grievances, and provided the information to make these long overdue conversions happen.

Dearborn Truck Run Update

On November 22, 2011 Arbitrator Karen Jacobs rendered her decision regarding the removal of the Dearborn inter-city truck runs from the carrier craft and giving the work to the Motor Vehicle Service craft. Arbi-

trator Jacobs' award decision reads as follows. "The Postal Service violated the National Agreement when it removed truck run duties from the letter carrier craft and transferred those duties to the Motor Vehicle Craft in Dearborn in 2000. For the reasons discussed above, the matter is remanded to the parties for consideration of remedy. I retain jurisdiction for 90 days for further proceedings if required." NALC Regional Administrative Assistant Jeff Fultz, who advocated the case on behalf of the NALC, has reported that efforts to resolve the remedy have been unsuccessful, and in a letter dated February 14, 2012 has asked the arbitrator to schedule a hearing so that the parties can reconvene to discuss a remedy. Stay tuned for further developments regarding the Dearborn Truck Run saga. Hopefully we get a just remedy for this decade long injustice to the letter carriers in Dearborn.

Dundee

On January 19, 2012 Michigan State Association of Letter Carriers President Dan Florkowski and I went to the Dundee Post Office to present a memorial plaque on behalf of the State Association commemorating the tragic death of Dundee Letter Carrier Nancy Schaefer. The presentation by State President Florkowski was very appreciated by the Dundee carriers who were there for the ceremony. At the request of the carriers, management put the memorial plaque in a place of honor near the front of the building where all the postal patrons could see it. On behalf of the Branch and its members I would like to thank the State Association and President Florkowski for the thoughtful gesture.

On February 13, 2012 National Executive Vice President Tim O'Malley and National Business Agent Pat Carroll made a trip to the Dundee office and met with the family of our fallen sister and presented them with a beautiful commemorative shadowbox/plaque. I would like to thank EVP O'Malley and NBA Pat Carroll for taking time out

of their busy schedules to make the trip to Dundee, and to meet with Nancy's family and for the thoughtful presentation. EVP O'Malley also told the family and coworkers present that Nancy's name would be added to the permanent plaque at the National office honoring fallen carriers from around the country. On the way back from Dundee EVP O'Malley and NBA Carroll stopped by the Branch office and met with our stewards who were attending a regularly scheduled steward meeting. EVP O'Malley and NBA Carroll were gracious enough to stick around and answer questions our stewards had before heading back to the NBA's office. I would like to thank them both for making themselves available and meeting with our stewards and officers.

Term Ending Report

In accordance with Article 6, section 1 of the Constitution for the Government of Subordinate Branches, I hereby submit the Branch's Term Ending Report. The following is an overview of the Branch operations for the last three years. I have also asked the Branch's officers to submit summaries from their areas of responsibility.

Financial Report

I am proud to report that the Branch's financial picture has never been better. By using a disciplined budget strategy and avoiding unnecessary expenses, we are in the strongest financial position the Branch has ever known. The end of the three year term balance as of December 2011 is \$269,716.26. We are in a very strong financial position with no outstanding debts, loans, or obligations.

Membership

We start the new term with 808 active members, and 303 retired members. The number of active members is down from the last term ending report when we had 856 while the number of re-

tired members has shown a slight increase from the 284 retired members during the last report. The financial collapse and the "great recession" have had an undeniable impact on the Postal Service. With volume and revenue collapsing and with the advent of the Route Adjustment Process, many routes have been eliminated and/or consolidated which has had a direct impact on our membership base.

Capital Improvements

We continue to maintain a rigorous schedule of maintenance here at the Branch and have avoided any major construction or maintenance costs. The property has been well maintained and all parts of our infrastructure remain in good working order. During the last term all the branch computers have been replaced or have been approved for replacement. I do not anticipate any other major computer related costs, replacements, or concerns at this time. In September our front gate and two of our barrier poles sustained damaged when a vehicle went out of control and ran into them. The insurance company has settled our claim and the work is scheduled to be done in the spring.

Activities

The Branch has continued its practice of having its yearly Branch Picnic for MDA. Since the picnic was reinstated back in 2006 interest in the event has increased every year. Our national charity MDA continues to be a Branch focus. The past three years have seen an ever increasing amount of participation in our Branch MDA events. Events which range from our annual calendar sales, to our picnic raffles, sponsorship of the poker rooms at Taylor Lanes, Bowlathon, and canister drive. Our annual participation in the Labor Day Parade continues with growing numbers of members attending. We continue to actively participate in the Food Drive, and the activities surrounding the event. Our Branch hosts a food drive

kickoff luncheon here at the Branch for each office coordinator and their community contacts and counterparts. Despite the economic downturn that many of the communities we represent have faced, our volunteers have proven they are second to none in their dedication to get the donated food to those in need.

Retirement

The Branch continues to offer assistance to our members who are contemplating retirement, and to those who are ready to retire. During the past three years we have fielded hundreds of calls regarding retirement related issues and assisted 75 members in retiring. We have averaged approximately 25 retirees per year over the last three. In addition to the regular retirement options, we continue to get many requests for help and questions about disability retirements and the early out VERA option offered by OPM. Any member in good standing is eligible to receive help from the Branch in making this important life decision.

OWCP

Another successful program which continues is our long standing Branch practice of providing assistance to our members with their OWCP claims. Our Branch is very proud of our record in helping our injured members in perfecting their claims. Once again this benefit has proven most popular with the Branch receiving hundreds of calls for help. Over the last three years more than 125 members have received help with their claims. The

total wage compensation returned to our members during this period is in excess of \$600,000. The National Reassessment Process or NRP played a large part in many of the calls we received. As of this date we have been successful in every NRP related grievance we have filed. Any member in good standing is eligible for this important benefit.

Contract Enforcement

Our Branch Stewards and Step A Designees continue to uphold our long held reputation for contract enforcement. The past three years have been no exception. With over 3400 grievances being filed. This is an increase of well over 20% from the prior three year period. During this period 1177 grievances were appealed to Step B. The Branch continues its commitment and support of our Stewards and Step A designees by providing them all the training and resources that are necessary to do their job. Their commitment, dedication, and motivation are truly an asset and resource to the Branch and its members.

In closing, it has been my pleasure and honor to work for and with each and every one of you these last three years. I hope and expect that during our next term together we can be equally as proud of the accomplishments we have achieved together as part of this great labor organization.



EVP's Report

The Battle Rages on...

As a basic function of the union, representation is top priority. The individuals that step up and provide this representation should be commended. The branch has always been proud of its record in upholding contractual obligations between the NALC and the USPS. Even though the steward is the one who processes the grievance it is you, the member, who is relied upon in taking that first step to enforce contractual requirements. The steward cannot see and hear everything and relies upon you to assist them. We all should be standing united on the workroom floor regardless of personal differences. As reported in the past, at the end of each term I submit an overall total of grievances filed in the branch. The following chart lists the number of grievances that were filed in each individual office.

Just as in the beginning of the NALC in 1889, today we find ourselves battling for a common goal; the survival of the Postal Service. Back in 1889 the issue of an 8 hour workday is when carriers organized into a body of workers that formed the NALC. When the Post Office Department refused to recognize the 8 hour day, the NALC went all the way to the Supreme Court. In 1893 the NALC won their case, and carriers were awarded a total of 3.5 million dollars settling thousands of overtime claims against the department. It was the NALC's persistence and prolonged efforts for a retirement law that in 1920 created the Civil Service Retirement Act. As the years went on, the NALC continued to battle for Letter Carrier rights. Many of these battles are documented in the NALC publication "Carriers in a Common Cause, A History of Letter Carriers and the NALC". I strongly recommend this reading to all Letter Carriers. Copies can be obtained from the hall or you can find the publication on the branches web site.

This year is no different. The NALC finds


Financial Secretary Treasures 2009 -2011 Term ending Report

Every Branch financial obligation has been paid in a timely manner. All required monthly and yearly financial reports have been completed and submitted timely. All Branch assets have been fully accounted for by the Trustees during the six thorough audits they have done. In the past three years I have been working with them to make sure the property and finances have been kept in order and perfect balance.

The branch has made some changes in the way we are now opening new CD's, we open one whenever our check book balance is over \$75,000.00.

I have attended all necessary training to ensure that we as a branch are up to date on all reporting requirements. I believe that our newly elected Recording Secretary and Vice President should also attend these trainings along with the Trustees so they will also know this important information. In my opinion I expect the Branch to be able to maintain it's strong financial position throughout the next three years.

Injury Compensation A Busy Three Years For Branch

There are few things more complicated and potentially stressful for a letter carrier than dealing with a job-related injury or medical condition. Many of the problems resulting from job-related injuries and medical conditions occur because of a lack of employee awareness of procedures and responsibilities. However, many problems also occur because of the often deliberate obstruction and interference with the injured carrier's rights by USPS management. Instances of management misconduct and sometimes illegal behavior involving employee injuries is well documented and includes (but is certainly not limited to) failure to provide or timely process forms, and obstruction and interference with the injured employee's medical care.

Additionally, we recently have received reports from at least one Branch 2184-represented office where the management directly issued threats of discipline to any carrier that is hurt on the job. The obvious intent of such threats – which violate both Federal Law and USPS regulations - is a transparent attempt to intimidate letter carriers into not reporting job-related injuries. Always report any such a threat by management, even if implied, to your steward and the Branch 2184 office immediately. Also, be sure to report every job-related injury to management, and immediately request and complete OWCP form CA-1 (and be sure to get the attached receipt). Branch 2184 has been very successful over the years at overturning bogus discipline that was issued to letter carriers merely as retaliation for reporting a job-related injury.

Additionally, with a few notable exceptions in Branch 2184, most delivery supervisors and even many postmasters are notoriously uninformed and ill-prepared to competently respond to employee injuries. Of greatest importance, always keep in mind that everything management says or does involving injured employees is done only with the interests of management in mind, and never the interests of the employee. Injured members should always seek competent and accurate information from their union before acting upon any information provided by management.

One of many services that Branch 2184 provides exclusively for NALC members is capable assistance with the sometimes daunting and complicated injury compensation process. This typically is needed after a member has incurred a job-related injury or developed a job-related medical condition that warrants a claim made under the Federal Employees Compensation Act (FECA), as administered by the United States Department of Labor's Office of Workers Compensation Programs (OWCP).

The overwhelming majority of all reported USPS injuries are incurred by city letter carriers. In fact, letter carrier injuries comprise the overwhelming majority of ALL non-military Federal and postal employee injuries. Letter carrier work has always been one of the most hazardous of all occupations, and it is becoming more so. Moreover, there is nothing more phony and duplicitous than hypocritical Postal Service management claims that they are "concerned" about employee safety. In reality, making their phony "performance" numbers trumps everything else, especially matters of safety. USPS management couldn't care less about your personal health and welfare.

Unfortunately, a record number of Branch 2184-represented letter carriers were injured on the job during the past three years. Reasons for this increase are many. However, they clearly include longer street times, where most injuries occur; the severe winter seasons in 2009-2010 and 2010-2011 (fortunately somewhat less so this winter), and a large influx of inexperienced letter carriers such as new TEs and former clerk craft employees who previously did not have to perform such difficult and hazardous work.

During the past three years (2009-2011) we assisted more than 125 members with injury compensation-related matters. Branch 2184 members who had sought assistance with their injury claims from the Branch office have received more than \$650,000 in wage compensation during this same period. This assistance, which is only available to our members in good standing, is quite wideranging in nature. Most initial assistance involves answering questions about procedures and OWCP regulations and also involves responding to management obstruction and misinformation. However, we also provide detailed and comprehensive assistance with claims development and appeals, especially with occupational illness/disease claims (CA-2) when this becomes necessary.

A few notes about the now allegedly defunct National Reassessment Process (NRP). This vicious and coordinated USPS assault on injured employees nationwide "officially" ended last year. However, the widespread damage caused by callous USPS management to injured employees continues in many instances. About 35 Branch 2184-represented members were impacted on some level by the application of NRP, several of them very seriously. Fortunately, we have so far obtained a successful outcome on every NRP-related grievance initiated in Branch 2184, either through arbitration or a pre-arbitration settlement. Several additional NRP-related Branch 2184 grievances are still awaiting adjudication.

As 2012 begins, we remain committed to diligently assisting any member that requests our help with matters related to job-related injuries or medical conditions. Call the Branch 2184 office (313-295-1640) with questions or for an appointment. As always, we can expect that management will continue to work against the interests of injured letter carriers. As always, you can expect that your union will continue to work to effectively enforce and uphold your rights when injured on the job.

Recording Secretary's Report

I would like to congratulate the 8 PTFs in our branch that have finally been converted to Full-Time Regulars. While it was the T-6 (CC2) residual vacancies that have sparked these conversions we are all hoping and working on getting more PTF's converted for the rest of the residual T-6 and residual route (CC1) vacancies.

I happened to be in the Taylor Post Office conference room when the announcement was made on the loud speaker regarding three PTF conversions in that station. After the announcement the workroom floor exploded with cheers and applause, it was an exciting and moving moment and I am happy I had the chance to be there to experience it.

The JARAP Memo expires on February 28, 2012. This means that unless a new agreement is made between the NALC and USPS, management can once again do route adjustments without the union's participation; which ultimately results in several grievances. Carriers should always work everyday as if on inspection, being professional and safe in the course of their duties.



Contract Corner:

Q: I wasn't paid for some of the overtime I worked during a recent pay period. How can I investigate this?

A: The first thing that any employee should do in this situation is notify their steward or the Branch 2184 office ASAP, so that we can investigate. Unfortunately, for many years some management representatives in Branch 2184-represented offices and throughout the United States have fraudulently altered and/or deleted employee time records with the intent of cheating employees out of wages earned in order to make management's "numbers" look better or to create false data for purposes of evaluating assignments for route adjustments. It is a sad commentary on the current state of the USPS that cheating and stealing from employees is such a common and tacitly encouraged management practice. Two additional notes: First, all letter carriers should routinely keep their own time log of hours worked to match up with their paystub. Second, when you suspect that management has engaged in time and wage fraud, do NOT call the OIG or Postal Inspectors yourself. Time and wage fraud is a removable offense, but apparently only for craft employees. For management, cheating and stealing is more likely to get them promoted. Let your union conduct the investigation.

Retirees Report

Branch 2184 has been providing expanded retirement assistance ever since the Postal Service discontinued local retirement counseling. In the past three year term 75 members have retired and in excess of 150 members have been provided assistance by appointment or by phone. Since 2009 two early out retirements (VERA) were offered and a number of Disability Retirements were approved.

The following is basic information you will need to determine your retirement eligibility.

Eligibility for CSRS Retirement

Optional	<u>Age</u>	Service (years)
	62	5
	60	20
	55	30

Eligibility for **FERS** Retirement

<u>Immediate</u>	<u>Age</u>	Service (years)
	62	5
	60	20
	MRA	30

MRA = Minimum Retirement Age

Year of birth determines MRA - Example: (If you were born in 1953 through 1964 your MRA is age 56. Years after 1965 increases your MRA.

If you meet the age and years of service requirements listed above, you are eligible for a CSRS Optional or a FERS Immediate retirement. Booklets have been prepared and updated to provide CSRS and FERS carriers with answers to their retirement choices and decisions. Both booklets are available at the Branch.

Follow the below steps to insure a trouble free retirement process.

- 1. Request retirement paper work (Blue Book) from Shared Services (1-877-477-3273 Option 5) 90-days prior to planned retirement date.
- 2. Fill out retirement application (Blue Book). If you need assistance or are confused by any decisions you have to make you can contact the Union Office for assistance. Help will be

provided by phone or an appointment can be made to meet with the Retirees Officer at the Branch

- 3. Call Shared Services for an individual phone counseling appointment 60 days prior to your retirement date. Phone counseling can be held at the Post Office on the clock, at your home or if you prefer at the union hall with the assistance of the retirees officer. At home or the union hall would be on your own time. The Shared Services counselor will go over your Blue Book with you line by line.
- 4. Remove completed pages from Blue Book, make copies for yourself and mail to address listed in book. Retirement date is your last work day.

Branch 2184 provides assistance to any member, in good standing, involving any aspect of the retirement process. Just call the Branch office or notify your steward that you want the union's assistance.

VP's Report

Branch 2184 won the 2011 It is true! NALC's 2011 COLCPE Contest, where branches of similar size were pitted against each other, challenging them to reach the highest rate of participation in the COLCPE GIMME 5 program. In our branch size of 451 or more members, we were pitted against the following branches: Branch 39 Indianapolis, Indiana, with a total of 1227 members, of which 7.66% of their members are giving to COLCPE via "GIMME 5," Br. 27 Memphis, Tennessee, with a total of 1030 members of which 6.89% of their members are giving to COLCPE via "GIMME 5;" and Br. 25 Massachusetts NE Merged, with a total of 1067 members of which 6% of their members are giving to COLCPE via "GIMME 5."

Branch 2184 has 1133 members of which 9.18% of our members are giving to COLCPE via "GIMME 5."
