## **President's Report**

#### **Highway Contract Update**

After being held in arbitration limbo for at least the last eight years we finally have some good news to report. Under the terms of our National Agreement, four Highway Contract Routes/Contract Delivery Services will be returned to the city letter carrier craft on August 31, three of the routes are in Trenton with one route located in the Westland Main office. These HCR/CDS routes are covered in the Memorandum of Understanding signed by the parties. The relevant language is as follows "Effective upon ratification of the 2006 National Agreement, there will be a modification to the subcontracting of city deliveries. This modification includes restrictions on contracting out of deliveries in offices which contain city only delivery." In other words the MOU prevents the USPS from having HCR/CDS routes in offices with only city delivery. In our Branch the following installations/offices are covered: Dearborn Main, Dearborn Annex, Dearborn Teleford, Dearborn Heights, Grosse Ile, Inkster, Lincoln Park, Taylor Main, Trenton, Westland, Wayne. While this is a step in the right direction, the Branch has identified at least eight more assignments that the National Office has agreed to look at under a Joint National Committee regarding Article 32, which is charged with developing an evolutionary approach to the issue of subcontracting. While the process of "righting the wrongs" can be frustrating and time consuming, we as a Branch will not rest until the remaining unresolved issues concerning these bogus HCR/CDS assignments have been adjudicated.

#### 66th Biennial Convention

21 delegates from the Branch recently attended our National Convention in Boston the week of July 21-25. I am pleased to report that all delegates were present and accounted for. The delegation attended all the



#### **Route Count and Inspections**

We have received notice from the Detroit District that two Installations in our Branch have been scheduled for full inspections: Canton the week of September 20 and Taylor the week of October 4. #### **Early Outs?**

The speculation is that a VERA will soon be offered to the remaining craft positions including letter carriers. If you are eligible to participate in this "early out" the VERA

#### **Boston Convention Report**

# WHAT'S HAPPENING OVER THERE?

Two overseas labor leaders addressed the delegates during our National Convention in Boston. The speakers were Philip Bowyer, deputy general secretary of the Union Network International (UNI), and Stephen Fitzpatrick, president of the Communications Workers Union in Ireland. These speakers addressed the delegates both during general session and they offered a panel discussion group in a separate class.

The NALC is an affiliate of the UNI; a global federation of postal and service-sector unions. The UNI has 15 million members in more than 100 countries; 3 million are postal employees.

The most alarming issue discussed dealt with the mandated deregulation of the postal services in the European Union by 2011 and the impact of privatization on unions around the world.

Mr. Philip Bowyers of UNI stated "the hour has come for global unions!" Due to the economy and the spread of multinational employers, there is a great need to give labor a united world wide voice before these global institutions. Mr. Bowyers stressed that "the only way we can maintain our living standards is to make sure workers around the world are organized."

During the discussion panel Mr. Bowyers explained the impact of privatization using the phone company as an example. He explained that "years ago there was only one phone company and it was 100% organized, now there are 10, 20, 30 different companies. The original company is still 100% organized but it is smaller. The whole of all the phone companies are only 50% organized. He then spoke about postal services such as the Germany Postal Service now being privatized and is called DHL, which I am sure we all know. He also stated the Dutch Postal Service is now privatized and is called TNT. Mr. Bowyers stated that people in Europe are "amazed that America, the most capitalistic country in the world, has the largest, most public service." He added solemnly "Keep hold of it as long as you can."

At the convention, the NALC delegates voted to endorse Senator Barrack Obama for president. The second speaker, Mr. Fitzpatrick from Ireland, began his opening speech to the convention floor by stating that "the decision by the NALC in their endorsement of Senator Obama was a welcome one." He went on to say that "this year's US presidential race is the one election in the world where everyone would like to have a vote."

During the discussion group, Mr. Fitz-patrick spoke about Downstreaming Access; private companies are keeping deliveries that are profitable and "dumping on the postal service what is not..." like rural areas. He told us that Ireland has gone to 5 day delivery. He explained that customer service has suffered and how the postal service over there has gone from being one the public held the utmost trust in to being a service with the highest number of complaints. "Privatization is for profit, not for customer service!"

Mr. Fitzpatrick stated the fight now is to "ensure pensions and standard rates (wages)". "We will petition our politicians for support like the US

## **EVP's Report**

#### **Cost of Living Adjustment**

If you haven't heard yet, the next Cost of Living raise you receive will be the largest, in dollars, for letters carriers in history. As reported in the Postal Bulletin dated August 14, 2008 it stands at \$1,498 per year increase or .72 cents per hour (\$57.60 per pay period). The pay increase becomes effective the pay period beginning August 30 (pay date September 19), is the third of eight COLAs included in the 2006-2011 contract. The accumulation for 2009 retiree COLA stands at 6.2 percent.

Article 9 (Salaries and Wages) section 3 of the National Agreement addresses the provisions regarding COLA. There will be 9 COLA adjustments during the life of this contract which expires in Nov. 2011. CPI (Consumer Price Index) refers to the "National Consumer Price Index for Urban Wage Earners and Clerical Workers" published by the Bureau of Labor Statistics, United States Department of Labor. The CPI is what drives how much you receive in your COLA adjustments.

There is good and bad news in receiving such a wage increase. The good news I hope is self explanatory. The bad news is that COLA is based on economic conditions of rising prices in certain areas of the economy.

This increase in pay, due to COLA, is a union negotiated provision in the contract. Many other unions in other industries have given up their COLA provisions, but not this union. With this increase alone (at \$1,498 annually) it will pay for more than two years of union dues for branch members. As for the scab letter carriers, what a pay raise, thanks to all the hard working, dues paying, union brothers and sisters of the NALC!!!

If you think for one moment that this would happen without a strong union, you're sadly mistaken. Talk a scab into becoming a part of what is the right thing to do by joining the NALC. Then they wouldn't have to be called a scab.

#### **Boston Convention**

NALC 66<sup>th</sup> Biennial Convention took place in Boston the week of July 21. When attending these conventions I always walk away with something new learned. Whether it in the technical contract workshops or the way the union conducts its business on the convention floor, I always take something back with me.

What I'll remember most from this convention is what happened to Branch 1427 of Santa Clara California during that week. Branch President James Stankovich had passed away in Boston. There was a moment of silence held on the convention floor along with a collection for his wife and eight children. When it was all tallied up, this convention raised \$54,000 for his family.

That is what I call **Solidarity** n: unity of purpose.



# JOB-RELATED INJURY COMPENSATION CLAIMS: IT'S NOT SO DIFFICULT AFTER ALL!

The nature of letter carrier duties is such that they directly cause or substantially contribute to a wide variety of physical ailments and conditions. Even letter carriers that consistently work in a safe, sane, and under control manner are inevitably at risk for the development of job-related medical conditions. This is because the human body is not designed to consistently absorb the physical stress of letter carrier work.

In many instances, job-related medical conditions develop after a period of months and even years of physical stress on various parts of the body. Letter carriers most commonly experience job-related medical issues involving (but not limited to) our feet, knees, hands, shoulders, neck, and last but not certainly least - our backs.

Much too often, a letter carrier goes right on working through the pain and discomfort, often self -medicating until the medical issue becomes so debilitating that it begins to affect their work. At this point two very problematic but also very avoidable things typically occur to letter carriers who have not initiated and developed an injury compensation First, they begin to use their hard-earned leave to give their bodies a break from the pain and physical stress of the job. Often, the condition will require surgery or other medical intervention, meaning that he or she will unnecessarily burn up even more of their valuable sick leave and even their annual leave. Even when a letter carrier can continue to work while in a state of pain and discomfort, management and their diabolical pal "Mr. DOIS" will still be there every day, incessantly badgering them to keep up the pace! Another common response is a request by the carrier for work accommodations in form of "light duty." However, letter carriers without accepted jobrelated injury claims have no guarantee of light duty work, and postal management with increasing

frequency is refusing to accommodate light duty requests.

Fortunately, there exists a MUCH better way. Letter carriers and all non-military Federal and postal employees are covered by the Federal Employees' Compensation Act, administered by the United States Department of Labor's Office of Workers Compensation Claims (OWCP). Many letter carriers incorrectly believe that developing and perfecting an OWCP claim is too difficult or is not worth the effort. *Nothing* could be further from the truth.

Yes, OWCP claims do require the completion of forms. Where medical conditions develop over a period of time, the proper form is a CA-2, Notice of Occupational Illness/Disease and Claim for Compensation. Successful OWCP claims always require well-reasoned medical and factual information that is sufficient to establish a direct relationship (called causal relationship) between your letter carrier duties and the medical condition you are afflicted with. OWCP's claims examiners, who have sole jurisdiction over your claim, are looking for a specific threshold of medical rationale accompanied by factual information about your letter carrier duties. Once this threshold is achieved, your claim will be accepted.

Be aware that USPS management is trained to obstruct and interfere with your claim. However, management ultimately has no authority whatsoever in determining the acceptance of an OWCP claim. Additionally, some of your coworkers and most of your supervisors are typically full of *misinformation* about the OWCP claims development and acceptance process. Always seek out authentic sources of information, such as your Union.

The benefits of an accepted OWCP claim are many, and include the payment of wage com-

pensation for lost work time due to your medical condition and its treatment. This includes any necessary surgery, physical therapy, and medical appointments. Your sick and annual leave is much too valuable to be wasted on a job-related injury! Upon acceptance of your claim, OWCP will also pay all medical costs related to the injury. Additionally, management has a far greater requirement to accommodate the work restrictions of letter carriers with accepted OWCP claims than those who do not.

Over the years we have developed a packet of information that is available to any member upon request. See your steward or contact the Branch 2184 office to request one. This packet contains all the information necessary for developing a compensation claim, including sample medical narratives, sample employee narratives, and definitions of OWCP's terminology. The packet also includes some great articles by Michigan State Association of Letter Carriers Director of Education Steve Burt and by the NALC's own injury compensation ex-

perts at the National level.

Finally, during my 36 years as an active letter carrier, I was frequently aware that there were some of our "own" who routinely attempted to belittle and marginalize their injured coworkers, especially those coworkers who had wisely availed themselves of the benefits of the Federal Employees Compensation Act. Much of this disgusting behavior was aided and abetted by local management in an attempt to intimidate or retaliate against those who enforced their rights under the FECA law. However, only the tiniest fraction (less than 1%) of all postal employee injury compensation claims are of questionable legitimacy. On the other hand, it is reliably estimated that well over 50% of all letter carriers who develop work-related medical conditions never initiate an OWCP claim. And that, my Union sisters and brothers, is simply a travesty.

## **Branch 2184 2008 Scholarship Application**

#### Qualifications:

- 1. Must be a dependent child of a Branch 2184 member in good standing (active or retired) or a child of a member now deceased and cannot be 24 years of age or older the year of application.
- 2. Applicant's parent must be a member in good standing of Branch 2184 for at least one (1) year prior to making application, with the exception of children of members now deceased who were previously members in good standing of Branch 2184 at the time of their death.
- 3. Must be a high school senior, high school graduate, GED recipient, or attending college or technical school (undergraduate) at the time of submitting the application, and attending an eligible school in the fall.\*\*
- 4. Only one application per child per year. Only one scholarship per family will be awarded each year.
- 5. Student must have maintained a 2.0 grade point average or above. A copy of grade transcript or equivalent must accompany application for scholarship.
- 6. If the NALC parent of a successful applicant is suspended by the Branch or makes an application for a supervisory position before monies are paid, the scholarship will be canceled. Children of members who have applied for a supervisory position are excluded from making application for two (2) years following withdrawal of the supervisory application.
- 7. Students with full scholarships are not eligible.
- 8. Eligible schools: accredited and licensed college, trade school, community college and schools of higher education only. The institution's eligibility shall be determined by the scholarship committee.
- 9. All decisions of the scholarship committee will be final.

## \*\* TO BE ELIGIBLE TO APPLY FOR THIS SCHOLARSHIP YOU MUST BE ENROLLED IN OR ENTERING AN ELIGIBLE SCHOOL FULL-TIME IN THE FALL OF 2008.

#### Awards:

- 1. The scholarship committee shall award the scholarships by random drawing of all eligible applicants.
- 2. Scholarships will be on a yearly basis and will be awarded at the October monthly meeting.
- 3. Scholarships will be awarded in allotments of \$500.00. Two (2) scholarships of \$500.00 each shall be allocated.
- 4. Two (2) alternates will be selected in the event that any scholarship winners are later ruled ineligible. The alternates' names will not be disclosed.
- 5. The scholarship will be disbursed to the student when a copy of a receipt for tuition, room and board or books is provided to the committee. The student must be full-time as established by their school or college.
