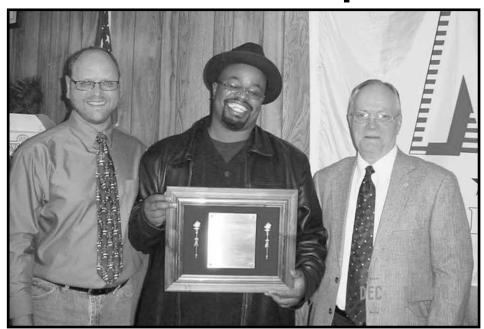

Contract Corner:

Q: I was a T-6 carrier who involuntarily lost my assignment due to route adjustments in my office. Am I still entitled to T-6 level pay?

A: Yes, under the circumstances described above you are entitled to "saved grade," which is an indefinite continuation of T-6 level (CC-2) pay, per the provisions of Article 9, section 6 of our Collective Bargaining Agreement and USPS regulations found in the Employee and Labor Relations Manual, sections 421.531 and 421.532. This entitlement to continued CC-2 pay continues as long as the employee bids on any subsequent T-6 positions that are posted for bid in their own USPS Installation. Of note, the letter carrier in this instance need not be the successful bidder on any subsequent T-6 vacancies that are posted, but they must submit a bid in order to remain eligible for continued CC-2 pay. If you are a former T-6 who has involuntarily lost his/her bid assignment due to route adjustments or similar reasons, be sure that your pay has been continued at the CC-2 rate. If not, see your steward immediately.

Q: I turned in a copy of my medical documentation for my absence from work and my supervisor told me that the documentation submitted to management must be the original documentation from my doctor, and not a copy. Is this correct?

A: No, that is not correct. This is common but entirely bogus claim on the part of management in some offices. USPS regulations regarding employee medical documentation (ELM 513.364 and ELM 865.4) contain *no such requirement whatsoever*, nor is there any existing contractual or legal requirement that only original documentation must be submitted. In short, management is, as usual, simply making stuff up, and in doing so is imposing a requirement exceeds the scope of their authority. Of note, when submitting a copy of any documentation to management, be sure that it is legible.

Q: My doctor prescribed special shoes for me to wear at work. My supervisor told me that this means I must request "light duty." Is that correct?

A: No, that is not correct, and in fact it is wrong on several levels. First of all, all "light duty" requests, which are made under the provisions of Article 13 of the Collective Bargaining Agreement as well as items 15 – 17 of the Branch 2184 Local Memorandum of Understanding, are voluntary on the part of the employee and cannot be compelled by management under ANY circumstance. Additionally, "light duty" requests are only appropriate when an employee has medical restrictions which impact their ability to perform some of their regular duties. In instances where an employee can perform all of his/her duties 8 hours a day, 5 days a week, a "light duty" request is unnecessary and inappropriate for any reason. Common examples of situations where management often improperly attempts to require a "light duty" request are (but are not limited to): An inability to work overtime (more than 8 hours a day or 5 days a week), the use of a satchel cart, uniform changes such as special shoes, and the need to take medication while working. *None* of these situations properly warrants a "light duty" request on the part of the employee because none of them affect the employee's ability to perform their regular letter carrier duties.

Q: I became an unassigned regular carrier because my assignment was abolished. Am I still entitled to a regular permanent schedule and a rotating nonscheduled day?

A: Yes, you are entitled to maintain both a regular permanent fixed schedule and a rotating nonscheduled day. Article 7.1.A.1 of our Contract requires that all fulltime regular carriers have established permanent regular schedules. If management schedules you to come to work at a different time, they must pay you either out-of schedule pay or overtime pay (depending on when you were noti-

Additionally, in accordance with Item 2 of Branch 2184's Local Memorandum of Understanding (LMU), ALL full time regular carriers, including all unassigned regulars, must be given a rotating nonscheduled day. Of note, if an unassigned regular carrier uses his/her seniority to opt on a temporarily vacant assignment (this is also known as a holddown), they assume the schedule of the opted for assignment for the period of the temporary vacancy.

Q: Are letter carriers that suffer frostbite while delivering mail eligible for worker's compensation (OWCP) benefits?

A: Yes, frostbite that occurs while delivering mail is considered a job-related traumatic injury and should always be reported on form CA-1. Frostbite and also heat-related illnesses that sometimes occur while delivering mail during the summer months are two of the most underreported job-related letter carrier medical conditions. It is *always* in your best interest to report any job-related injury or medical condition by utilizing OWCP forms CA-1 (traumatic injury) and CA-2 (occupational illness/disease). Branch 2184 provides competent and timely assistance regarding all injury compensation/OWCP issues for any member that requests it.

Anaheim 2010 Convention Reports

I was a delegate to the 67th NALC Convention and would like to take this opportunity to thank my brothers and sisters for the experience. While you all were here sweating in mid 90's humid weather, I was enjoying 78 - 80 degree, sunny, no humidity weather in Anaheim, CA. Enough of that.

I did not mean to gloat but ...

Besides being in the midst of my union brothers and sisters came together for a common cause and that was to learn. I took a workshop on Contract Administration. It was an interesting session. Some recent arbitration cases were discussed as well as some of the pending arbitration cases. Due to time constraints and the complexity of some of the cases - FMLA, National Reassessment Process, JARAP, and Article 8 issues - were touched on. I did get some reading material where I could look up these things and more, on my own.

One of the other workshops I took was on stealing. Yes, stealing! Not stealing by one of our own, but by (gasp) management. Stealing our workhours, overtime, office time, street time, etc. All to make their precious numbers and to operate within the "window". This was a real learning session. It taught how important it is to keep up with your workhours and clock rings, not only to get your correct pay and overtime, but to get the correct hours for street time, office time, and volume when route adjustments come around. Management can control this - if you let them. I learned what to look for as well as many of my fellow stewards. See your steward if you have any doubts about your hours, etc.

These were just two of the workshops that I took. We also learned a lot in the biggest pep rally ever - the convention floor. Upcoming contract talks were discussed, issues affecting offices big and small, introductions of our National Officers, COLCPE, MDA, etc. I met a lot of brothers and sisters from other States and Branches, I talked with the "bigwigs", I learned that we are in this thing together because we face the same problems and frustrations.

I also attended a Union Rally in Los Angeles. It was awesome. There were many unions represented - electricians, steel workers, utility workers, etc, but the sight of over 3000 letter carriers, all in blue T-shirts was a sight to behold. We supported our fellow unions and over ran the lawn to the LA

City Hall. We all came together for a common cause - JOBS. The other Union's message was no furlough days, no job cuts, no cut in pay. Our message is 5 day - The Wrong Way!!

I learned and experienced so much more - some OWCP stuff, some retirement stuff, some file writing stuff - I would have to write a book to tell it all. I want to again thank you, my brothers and sisters, for this precious opportunity and can only hope that you will continue to have faith in me, as a steward, to go to other learning endeavors so that I can continue to serve you.

Allow this to serve as a brief synopsis of my learning experience of the National Convention that took place in Anaheim, Ca. I took Contract Administration Unit Briefing Q&A, Article 12 Withholding and Excessing, Safety and Health, and NRP for Contract Enforcers.

In the Contract Administration unit briefing workshop there are a lot of national level settlements that are useful for everyday grievances. There is a lot of information that I can apply to my everyday grievances that are filed. I found the Q&A information on transitional employees very useful, being that Dearborn Main employs 10 TE's that have a lot of different questions daily.

In the Article 12 withholding and excessing workshop I found the information very helpful due to the current withholding and excessing that the Postal Service is under. I applied the information to a grievance that I filed and found that I needed to withdraw the grievance to protect the PTF employees that are at the Dearborn offices. Also, there



were a couple of excessed employees that were placed at the Dearborn Main office and the information that I received in the handout allowed me to become more knowledgeable about the process that they were going through and it also allowed me to better help the excessed employees.

When I went to the Safety and Health workshop I found it helpful and I learned that there are so many employees that are struggling with emotional stress that is caused not only by personal stress but stress that is caused by their workplace and work environment. I learned what to look out for when an employee may be faced with different adversities that may be caused by life, and they may need to seek alternate help from an outside entity that is provided by the Postal Service (i.e. EAP).

Finally, the National Reassessment Process workshop that I attended provided useful information for future employees that may be placed on the NRP list. There are currently no NRP employees at the Dearborn Main office so I was unable to apply what I learned from the workshop.

In short this convention was informative as well as inspirational. I walked away with a wealth of new knowledge that I can immediately apply to the base of information already provided through the years of working as union steward with Branch 2184. It inspired me to focus above and beyond my present levels of leadership to levels greater where the membership will gainfully reap better benefits.

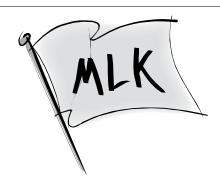
